The OLF Foundation had a successful year in 2022-2023. The Blue and Gold campaign, with a focus on technology, raised \$237,377 dollars. A total of \$119,188 was raised for technology, our Endowment fund added \$53,949, and the Little Lagniappe campaign, Fatima Fest, grants, Fun Run, House System, parking lot, Broussard Garden, Spring Auction, and plant maintenance raised \$64,240. We have approximately \$2,900,000 in our Endowment account. The interest earned in 2022-2023, \$88,000, went to the school for grants and the operating budget.

A huge thanks to our 2022-2023 Blue and Gold Chairmen, Stuart and Keisha Billeaud, the Blue and Gold Committee, and our Foundation Board members for their time and efforts in making this another outstanding year at OLF.
